



## Letko Brosseau Awarded Top Guns Designation by Informa Financial Intelligence

Montreal, Canada - November 27, 2019 - Letko, Brosseau & Associates (LBA) has been awarded a PSN Top Guns distinction by Informa Financial Intelligence's PSN manager database, North America's longest running database of investment managers.

**LBA was honored with a six-star Top Gun rating for its Emerging Markets Equity strategy** for the period ending September 30, 2019<sup>1</sup>.

Through a combination of Informa Financial Intelligence's proprietary performance screens, \*<u>PSN Top Guns</u> (\*free registration to view Top Guns) ranks products in six proprietary categories in over 50 universes. This is a well-respected quarterly ranking and is widely used by institutional asset managers and investors. Informa Financial Intelligence is part of Informa plc, a leading provider of critical decision-making solutions and custom services to financial institutions. Top Gun firms are awarded a rating ranging from one to six stars, with the number of stars representing continued performance over time.

LBA's Emerging Markets Equity strategy was named Top Gun with a 6-star rating within PSN's Emerging Markets Equity universe, which tracks 156 firms and 294 separate products. The 6-star rating, the most competitive category, filters the universe according to the following criteria:

- products must have an R-Squared of 0.80 or greater relative to the style benchmark for the recent fiveyear period
- products must have returns greater than the style benchmark for the three latest three-year rolling periods
- products must have a standard deviation for the five-year period equal or less than the median standard deviation for the peer group
- the top ten **information ratios** for the latest five-year period then become the TOP GUNS.

LBA has been managing emerging markets equities since the inception of the firm over three decades ago and within a dedicated strategy since 2011. Using an approach centered on fundamental analysis, price discipline, a long-term horizon, a global outlook, integration of ESG factors, and a sole focus on public markets, LBA has built a truly differentiated and diversified portfolio of high-quality emerging markets opportunities.
