What does the fund invest in?

The fund has as its objective to generate capital appreciation through the creation of a well-diversified portfolio of publicly-traded companies primarily exposed to Canada, diversified across economic regions, industries and companies. Investments in securities of foreign issuers are not generally expected to exceed 10% of the net asset value of the fund.

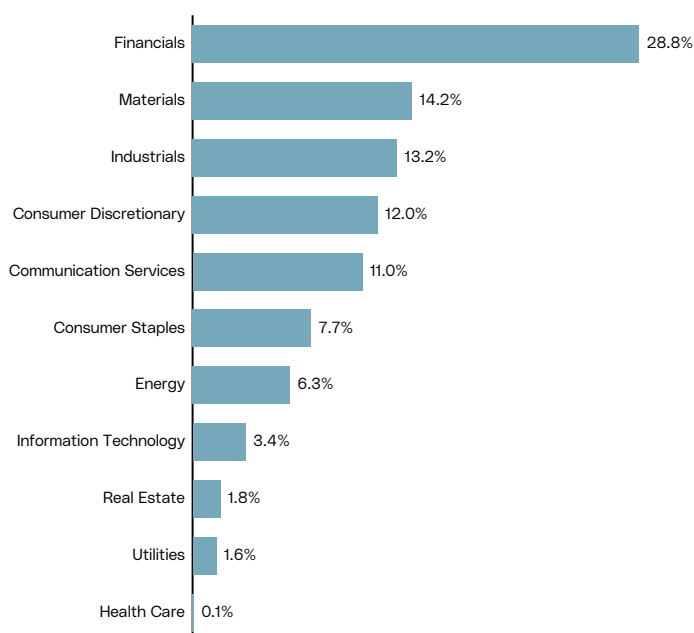

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk Rating

Letko, Brosseau & Associates Inc. has rated the volatility of this fund as medium.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low-risk rating can still lose money.

Like most mutual funds, this fund does not have any guarantees. You may not get back the amount of money you invest.



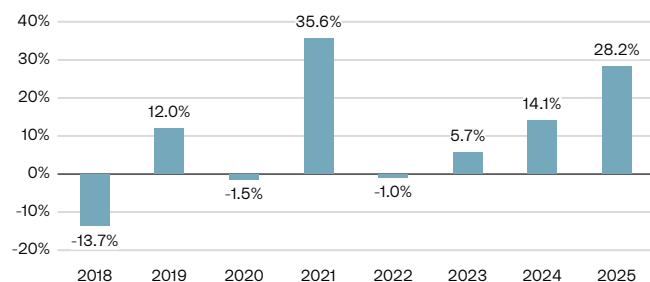
How has the fund performed?

The fund was not a reporting issuer prior to May 15, 2026. The performance information and data disclosed below include the past performance of series A units of the fund prior to the fund becoming a reporting issuer. The expenses of series A units of the fund would have been higher during this period had the fund been subject to the additional regulatory requirements applicable to a reporting issuer. Letko, Brosseau & Associates Inc., on behalf of the fund, has obtained exemptive relief to permit this disclosure of the past performance data of series A units of the fund.

This section tells you how series A units of the fund have performed over the past 8 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

This chart shows how series A units of the fund performed in each of the past 8 years. The fund dropped in value in 3 of the 8 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for the series A units of the fund in a 3-month period over the past 8 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in series A units of the fund since the Operations Commencement Date of the fund would now have \$2,347. This works out to an annual compounded rate of return of 10.0%.

Who is this fund for?

This fund is appropriate for Canadian investors seeking capital appreciation and who:

- Can tolerate medium risk
- Plan to hold the investment for the long term

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell series A units of the fund. The fees and expenses, including commissions, can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

There are currently no sales charges payable for series A units of the fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

	Annual rate (as a % of the fund's value)
Management expense ratio (MER) This is the total of the fund's management fee (including trailing commission, if any) and operating expenses.	2.15% *
Trading expense ratio (TER) These are the fund's trading costs.	0.04%
Fund expenses	2.19% *

* The information is based on the MER of the fund for its last completed financial year when its units were offered privately. The MER of the fund may increase as a result of the fund offering its units under a simplified prospectus.

As of December 31, 2025, the fund's expenses were 2.19% of its value. This equals to \$21.90 for every \$1,000 invested.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

Letko, Brosseau & Associates Inc. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment.

The rate for the series A units of the fund is 1.25% of the value of your investment each year. This equals to \$12.50 each year for every \$1,000 invested.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fees	What you pay
Short-Term Trading Fee	You will be subject to a fee corresponding to 2% of the current value of the series A units if you redeem or switch them within 90 days of purchase (the " Short-Term Trading Fee "). The Short-Term Trading Fee will be paid to the fund and not to us.
Large Redemption Penalty	If you have been notified that you are a large investor because you own or control units of the fund having a value greater than 10% of the fund's net asset value (the " Large Investor "), and you wish to redeem or switch within a 30 day period an amount that is equal to or greater than, in the aggregate, 10% of the fund's net asset value (the " Large Redemption "), you may have to pay up to 1% of the net asset value of the securities redeemed or switched if you do not provide the required prior written notice in anticipation of the transaction (the " Large Redemption Penalty "). The Large Redemption Penalty will be paid to the fund and not to us. If the Large Redemption would be subject to both a Large Redemption Penalty and a Short-Term Trading Fee, only the Short-Term Trading Fee will apply.
Large Redemption Transaction Fee	Notwithstanding the foregoing, Large Investors submitting redemption orders constituting a Large Redemption may be subject to a fee corresponding to the actual trading costs incurred by the fund in connection with such Large Redemption (the " Large Redemption Transaction Fee "), as determined by the Manager in its sole discretion, acting in the best interests of the fund. The Large Redemption Transaction Fee shall not exceed 0.20% of the net asset value of the units redeemed and will be paid to the fund and not to us. If the Large Redemption would be subject to both a Large Redemption Transaction Fee and a Short-Term Trading Fee, only the Short-Term Trading Fee will apply.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within 2 business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
